Employees Provident Fund invites electronic bids from eligible bidders for the construction of "Construction of Interior Works for IT & Economic Department at Pulchowk and Sanchayakarta Sewakendra at Lagankhel Lalitpur for Karmachari Sanchaya Kosh" under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years:

NRs.31,300,000.00

Minimum Work experience of similar size and nature: NRs.8,358,000.00

2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Employees Provident Fund, Pulchowk, Lalitpur, Bagmati Province, Nepal or may visit PPMO e-GP system [www. bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
4. If hard-copy is allowed then a complete set of Bidding Documents may be purchased from the office Employees Provident Fund, Pulchowk, Lalitpur, Bagmati Province, Nepal by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs. 5,000 till 02-02-2025 12:00 during office hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. 6. Pre-bid meeting shall be held at Assets Management Department, Employees Provident Fund, Pulchowk, Lalitpur, Bagmati Province, Nepal at 23-01-2025 12:00 hours.

7. Sealed or electronic bids must be submitted to the office Employees Provident Fund, Pulchowk, Lalitpur, Bagmati Province, Nepal by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 02-02-2025 12:00. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 02-02-2025 13:00 hours at the office of Assets Management Department, Employees Provident Fund, Pulchowk, Lalitpur, Bagmati Province, Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs.500,000.00 which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
