Bidders, submitting their bid electronically, should deposit the payment of a nonrefundable fee **NRs.1000/-** of bidding document in the following account:

3. Sealed bids must be submitted to the office Employees Provident Fund, Pulchowk Lalitpur through e-GP system i.e [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **02-01-2025 12:00**. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at **02-01-2025 13:00** at the office of Employees Provident Fund Pulchowk, Lalitpur, Bagmati Province Nepal. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a **Bid security** amounting to a minimum of **NRs. 25,000/-**, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the **Cash Security**, the cash should be deposited in Deposit Account No.00401010254373 at Nepal Investment Mega Bank Ltd., Pulchowk and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
