- Electronic Bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Noon on 2081/04/22, Bid after this deadline shall not be accepted.
- 6. Sealed Bid shall be opened in the presence of bidders' representatives who choose to attend at 1:00 PM on 2081-04-22 at the office of Training Hall, Karmachari Sanchaya Kosh, Pulchowk, Lalitpur.
- 7. Bid must be valid for a period of 90 days after opening of Bid and must be accompanied by Cash Security or Bank Guarantee, amounting to a minimum for Package-1 SUV (HYBRID VECHICLE) NRs. 450,000 (Four laksh fifty thousand only) and Package-2 DOUBLE CAB PICKUP, NRs. 110,000 (One Lakh Ten Thousand only) which shall be valid for 120 days after opening of the Bids. If bidder wishes to submit the Cash Security, the cash should be deposited in aforementioned account and submit the receipt of the deposited voucher.
