- 4. Pre-bid meeting shall be held at Karmachari Sanchaya Kosh, Pulchowk, Lalitpur on 2025-05-11.
- 5. Electronic Bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Noon on **2025-05-21**, Bid after this deadline shall not be accepted.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM on 2025-05-21 at the office of Meeting Hall, Asset Management Department, Karmachari Sanchaya Kosh, Pulchowk, Lalitpur. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 450,000.00 (Four Lakh Fighty Thousand Only), which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.
